#### 2. Consolidated ARTF Sources and Uses of Funds for FY1402:

Table 2 presents sources and uses of funds for FY1402 on a consolidated basis as of March 20, 2023. The sources of funds are net donor contributions, investment income less administration fees and the cash balance carried forward from FY1401. As of March 20, 2023, the cash balance stood at US\$ 976.85 million comprising: (a) combined undisbursed balance of the ARTF active investment portfolio of US\$87.83 million; (b) US\$1.00 million combined undisbursed balance of the ASIST Window; and (c) US\$20.71 million reserved for the ACRMAP window, leaving a net unallocated cash balance of US\$ 867.31 million of which 374 million is committed. (Tranche 2: i) Health \$164 million ii) Food Security \$45 million and iii) Livelihoods 165 million)
