



AFGHANISTAN RECONSTRUCTION TRUST FUND (ARTF)
Administrator's Report on Financial Status
As of February 19, 2018, (end of 2nd month of FY1397)

1. Donor contributions for FY1397.

Total donor indicated¹ and actual (paid-in) contributions for the core ARTF for FY1397 amount to US\$292.93 million, of which US\$114.30 million (39%) are without preference and US\$178.63 million (61%) are preferenced. In addition, US\$188.94 million has been intended in funding under the Ad Hoc Payments (AHP) facility. Table 1 reflects total donor indicated contributions and paid-in amounts, including AHP.

2. Consolidated ARTF Sources and Uses of Funds for FY1397

Table 2 presents sources and uses of funds for FY1397 on a consolidated basis as of February 19, 2018. The sources of funds are net donor contributions, investment income less administration fees and the cash balance carried forward from FY1396.

As of February 19, 2018, the cash balance stood at US\$1,462.58 million comprising: (a) US\$84.42 million in the Recurrent Cost Trust Fund (excluding US\$50 million in the designated Account); (b) combined undisbursed balance of the ARTF active investment portfolio of US\$767.27 million; (c) US\$1.04 million combined undisbursed balance of the Research and Analysis Program and (d) US\$21.25 million reserved for the Monitoring and Supervisory Agents, leaving a net unallocated cash balance of US\$538.61 million.

¹ Contributions are recorded as INDICATED when written notification is received from the ARTF partners indicating intent to contribute a specified amount.

3. Recurrent Cost Financing Requirements

The FY1397 opening balance in the Recurrent Cost Window trust fund is US\$84.42 million and an additional US\$200 million will be allocated in the first quarter of the year to cover US\$120 million AHP funding (paid in January 2018), and the remaining balance for the IP payments. As of February 19, 2018 a total of US\$100 million has been disbursed under the Ad Hoc Payment facility.

The overview of the full year FY1397 is shown in Table 3.

Undisbursed Balances of Individual Projects as of February 19, 2018

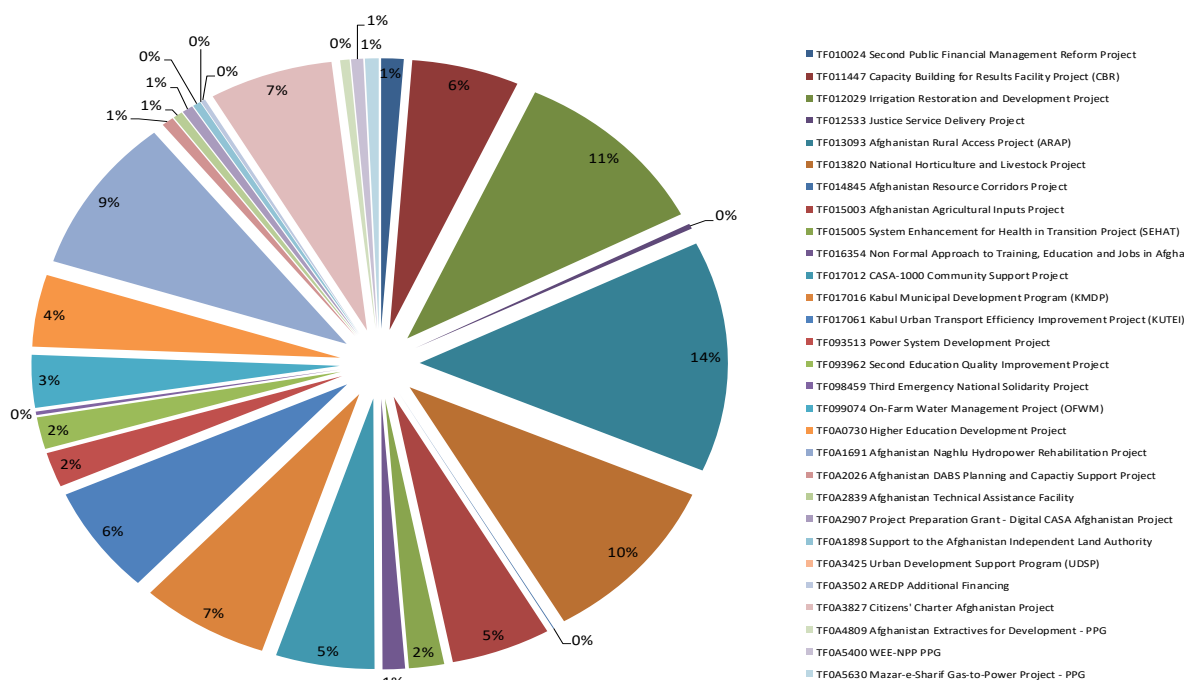
