



AFGHANISTAN RECONSTRUCTION TRUST FUND (ARTF)
Administrator's Report on Financial Status
As of January 20, 2020, (end of 1st month of FY1399)

1. Donor contributions for FY1399: Total donor indicated¹ and actual (paid-in) contributions for the core ARTF for FY1399 amount to US\$262.36 million, of which US\$141.62 million (54%) are without preference and US\$120.74 million (46%) are preferred. In addition, US\$32.91 million has been intended in funding under the Ad Hoc Payments (AHP) facility. Table 1 reflects total donor indicated contributions and paid-in amounts, including AHP.

2. Consolidated ARTF Sources and Uses of Funds for FY1399:

Table 2 presents sources and uses of funds for FY1399 on a consolidated basis as of January 20, 2020. The sources of funds are net donor contributions, investment income less administration fees and the cash balance carried forward from FY1398. As of January 20, 2020, the cash balance stood at US\$1,598.80 million comprising: (a) US\$34.82 million in the Recurrent Cost IPF Child Trust Fund (excluding US\$50 million in the DA); (b) combined undisbursed balance of the ARTF active investment portfolio of US\$654.73 million; (c) US\$3.22 million combined undisbursed balance of the ASIST Window; (d) US\$11.22 million reserved for the Monitoring and Supervisory Agents; (e) US\$0 balance in the Recurrent Cost Window; and (f) US\$2.37 million reserved for the ACREMAP window, leaving a net unallocated cash balance of US\$842.44 million.
