



## **AFGHANISTAN RECONSTRUCTION TRUST FUND (ARTF)**

**Administrator's Report on Financial Status**

**As of August 22, 2022 (end of period 8 in FY1401)**

**1. Donor contributions for FY1401:** There are no donor contributions received as of August 22, 2022 in FY1401.

**2. Consolidated ARTF Sources and Uses of Funds for FY1401:**

Table 2 presents sources and uses of funds for FY1401 on a consolidated basis as of August 22, 2022. The sources of funds are net donor contributions, investment income less administration fees and the cash balance carried forward from FY1400. As of August 22, 2022, the cash balance stood at US\$973.83 million comprising: (a) US\$0 balance in the Recurrent Cost IPF Child Trust Fund; (b) combined undisbursed balance of the ARTF active investment portfolio of US\$157.96 million; (c) US\$0.89 million combined undisbursed balance of the ASIST Window; (d) US\$0 balance in the Recurrent Cost Window; and (e) US\$6.81 million reserved for the ACREMAP window, leaving a net unallocated cash balance of US\$808.17 million of which 494 million is committed (Health \$164m (Tranche2), Food Security \$45m (Tranche 2), Livelihoods 165 million (Tranche 2), NGO capacity \$20m and Education \$100m).
