

1395 UPDATE TO THE FINANCING STRATEGY

Endorsed March 6, 2017

I. Summary:

The ARTF Financing Strategy 1394-1396 was endorsed by the ARTF Steering Committee on June 15, 2015. This 1395 update to the Financing Strategy (FS) was endorsed by the Steering Committee March 6, 2017. This update outlines programs and activities to be financed in 1395 and 1396, reflecting the priorities of the Government of the Islamic Republic of Afghanistan. It is the result of extensive discussions between the Government and the ARTF Administrator, and provides a guide to the pipeline for this year and the next year. However, as government needs and priorities are likely to change over time, the projects that are subsequently prepared and their final funding amounts may be slightly different than what is presented in the tables below.

II. Funding by Sectors

The ARTF will continue to support the government in six main sectors- agriculture, governance, human development, infrastructure, rural development, and social development. Table 1 below presents all the investment projects to be financed through the ARTF in each of the sectors during the FS period. Projects that were already approved in 1394 (2015) and 1395 (2016) as well as those yet to be approved are shown below. In some cases the actual project funding amounts approved by the ARTF MC are slightly different from those in the original FS. Please refer to page 26, Table 8 of the ARTF FS for further details on agreed amounts. Amounts in bold indicate approved projects.

III. ARTF Cash Position as of September 21, 2016

ARTF entered FY1394 with an unallocated cash balance of USD 525.39 million carried over from FY1393. A total of USD 651.50 was received during FY1394 and a total of USD 815.65 million was allocated to the Recurrent Cost Window, Investment Projects, the Monitoring and Supervisory agents and the Research and Analysis Program. At the end of FY1394, the fund had an unallocated cash balance of USD 353 million. In FY1395, ARTF started with an opening unallocated balance of USD 353 million and received a total of USD 632 million as donors' contributions during the year. By September 21, 2016, the total cash balance stood at USD 298 million in the ARTF Parent Account.

V. Investment Projects Pipeline- 1395-1396

Financing in the amount of USD 328.50 million for 9 investment projects (**Table 4**) is expected to be approved in the remainder of 1395 and in 1396. This includes financing for new investment projects, as well as additional financing, and allocation of tranches to existing projects. The pipeline for 1396 may be changed depending on emerging government priorities.

Notes to Aid Interpretation

- 1: **Bold** numbers reflect amounts for actual approved projects. All projects shown in 1394 column. **Bold** numbers in 1395 and 1396 columns indicate either project so far approved or, for 1396, allocations tranched for 1396 (for CCAP).
- 2: The rest -- all non-bold numbers -- indicate amounts for projects in the pipeline (1395 & 1396) under the FS as of now. This list is what constitutes the Update to the FS.
- 3: The pipeline (projects under preparation or discussion for 1395 & 1396) are subject to change, including on design, timing, and amounts.
- 4: In the original FS, \$200m was indicated against NSP IV, the actual name of the new project was later agreed to be Citizens' Charter Afghanistan Project.
- 5: Citizens' Charter = \$400m, of which \$200m will be allocated during current FS with a first tranche of \$100m in 1395 & \$100m in 1396.
- 6: In the original FS, \$50m was planned for the next phase of Rural Livelihoods Project. This is now the \$4.7m Additional Financing for AREDP in the Updated FS.
- 7: Additional funds received from EU for NHLP account for the bulk of the differnce between the \$1,013m in this FS Update and the projected total of \$918m in the original FS.
- 8: The new Strategic Grain Reserves project will be financed by IDA and JSDF, not ARTF.
- 9: Original FS did not anticipate Additional Finance for NSP III. The \$57m AF is from new donor contributions, not previously envisioned in original FS, in support of Jobs for Peace Program.
- 10: Land Managament project, original FS anticipated \$30m. ARTF will now only finance the preparation (\$4.95m). The \$30 million project will be financed from IDA.
